NARRATIVE

ON THE ABOVE DATE AND TIME THE VICTIM RESPONDED TO CO.E IN THE COMPANY OF (R) [REDACTED] HER BOYFRIEND. THE VICTIM STATED THAT SHE WAS HERE TO REPORT A DOMESTIC VIOLENCE INCIDENT THAT OCCURRED WHILE SHE WAS IN A DATING RELATIONSHIP WITH (S) MIRKARIMI. THE VICTIM WAS ESCORTED TO THE INTERVIEW ROOM AT NORTHERN STATION AND ALONG WITH LT FAHTOOH #26, SGT BEAR #1898 [REDACTED] AND MYSELF, I CONDUCTED THE FOLLOWING TAPED INTERVIEW.

THE VICTIM STATED IN JUNE OF 2007 SHE MET MIRKARIMI AT THE HAIGHT STREET FAIR AND BEGAN A DATING RELATIONSHIP WITH HIM WHICH ENDED IN DECEMBER OF 2008. THE VICTIM STATED THROUGHOUT THEIR RELATIONSHIP MIRKARIMI DISPLAYED A VIOLENT AND "RAGING PITBULL AGGRESSIVENESS" TOWARDS HER. THE VICTIM SAID ON NUMEROUS OCCASIONS AT MIRKARIMI'S HOME ON WEBSTER ST MIRKARIMI WOULD SCREAM INTO HER FACE WHILE BACKING HER AGAINST A WALL WITH HIS IMPOSING STATURE. THE VICTIM SAID ONE NIGHT SOMETIME BETWEEN JUNE OF 2007 AND MAY 2008 MIRKARIMI'S RAGE TURNED VIOLENT. THE VICTIM SAID THAT EVENING MIRKARIMI WENT INTO A RAGE ABOUT SOMETHING AT WHICH TIME MIRKARIMI GRABBED HER BY BOTH HER UPPER ARMS, SHOOK HER AND PINNED HER AGAINST THE WALL. THE VICTIM SAID, FEARING FOR HER SAFETY, SHE CONVINCED MIRKARIMI TO LET HER GO WHICH HE DID. THE VICTIM SAID AFTER THE INCIDENT SHE DISCOVERED A BRUISE ON HER UPPER RIGHT ARM. THE VICTIM SAID SHE DID NOT NOTIFY THE AUTHORITIES ABOUT THE INCIDENT AT THAT TIME BECAUSE SHE COMES FROM A LAW ENFORCEMENT FAMILY AND SHE WAS HUMILIATED AND EMBARRASSED ABOUT THE INCIDENT.

THE VICTIM SAID THE RELATIONSHIP ENDED IN DECEMBER OF 2008 WHEN MIRKARIMI CONFESSED TO HER THAT HE HAD BEEN IN ANOTHER RELATIONSHIP WITH A WOMAN FROM VENEZUELA AT THE SAME TIME HE WAS DATING THE VICTIM. MIRKARIMI TOLD THE VICTIM HE HAD GOTTEN THE VENEZUELAN WOMAN PREGNANT.

THE VICTIM BROUGHT IN THE E2 PHOTO AND THE E3 E-MAILS AS PROOF OF HER RELATIONSHIP WITH MIRKARIMI. THE VICTIM REQUESTED CONFIDENTIALITY DUE TO THE FACT SHE HAS BEEN A VICTIM OF MIRKARIMI'S VIOLENT BEHAVIOR AND FEARS HE WILL TRY TO USE HIS POLITICAL POWERS TO DISCREDIT HER.

THE VICTIM STATED SHE DECIDED TO REPORT THIS INCIDENT IN LIGHT OF THE PRESENT ONGOING DOMESTIC VIOLENCE CASE REGARDING MIRKARIMI AND HIS WIFE. THE VICTIM STATED, "I HAVE NOTHING TO GAIN FROM REPORTING THIS OTHER THAN TO NOTIFY THE AUTHORITIES OF THE HISTORY OF VIOLENCE MIRKARIMI HAS TOWARDS WOMEN".

I BOOKED THE E1, E2 AND E3 ITEMS AT CO.E.

SGT ARTIGA #1417 NOTIFIED INSP. DANIELLE #427 OF THE DVU UNIT REGARDING THIS INCIDENT. SGT ARTIGA ALSO NOTIFIED CAPT MANNIX REGARDING THE INCIDENT.

IT SHOULD BE NOTED THAT A COMPUTER CHECK OF MIRKARIMI REVEALED AN OUTSTANDING TRAFFIC WARRANT FROM 12/01/06 FOR \$191.00 FOR THE VIOLATION OF VC 24400.
